



Umbrella changes for ACE Platinum Portfolio policyholders in Oklahoma

Dear Valued Partner,

Please be advised the following changes have been approved by the Oklahoma Insurance Department, effective April 11, 2016 for new business and June 11, 2016 for renewals.

As a reminder, all Oklahoma new business for new customers effective April 20, 2016 and later is to be placed in the Chubb Masterpiece system, unless a special exception is noted in the [How to Transact Business in the new Chubb](#) document and updates available on the Integration Resource Center on Abiz and @chubb.

Please Note: These changes apply only to ACE Platinum Portfolio policies and do not impact Chubb or Fireman's Fund policyholders.

Following is a summary of the changes made to the Oklahoma rates:

Umbrella Changes: +2.8%

Rates revised for the following:

- Revised Base Rates
- Package Credit increased from 10% to 15%
