How to enroll

Simply go to www.chubb.com/personal and click on "eServices." Within a few days, you will receive a paper confirmation regarding your enrollment. From that point on, your next policy and all related documents will be emailed to you in a highly secure PDF attachment. (Only those documents *required in paper format by law* will be sent via regular mail).

How it works

To open your **ePolicy**, all you need to do is enter the two-letter state abbreviation for the mailing address listed on the policy, plus the first five digits of the policy zip code (example: ny12345). You can then view, save or forward your policy. There are no usernames or passwords to remember. It's that easy.

Once enrolled, you'll receive your **ePolicy** PDF and all related documents within a few hours after policy issuance, instead of the customary few days later with traditional paper delivery. You'll be able to access your **ePolicy** anytime, anywhere you have access to email... and get answers fast. And in the event of a claim, **ePolicy** offers convenience that is hard to beat. This can be especially critical following a loss in which your personal paper files may have been damaged or destroyed.

Since **ePolicy** is delivered electronically, you won't need to clutter up your home or office with more paper. So say good-bye to bulky insurance files. But if necessary, you can always request a paper copy from Chubb or print your own copy anytime.
